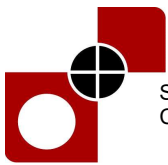

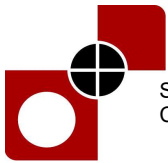

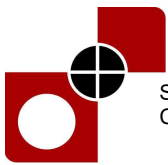

- (i) Earnest Money Deposit amounting to Rs.1,35,900/-(Rupees One Lakh thirty-five thousand nine hundred Only) in the form of account payee Demand Draft /Bankers Cheque/Fixed Deposit (for FDR *validity should be minimum 120 days + 45 days from the date of tender opening*) Receipt in favor of India Government Mint, Noida payable at Noida is to be furnished along with PQB.
- (ii) EMD of a bidder will be forfeited, if the bidder withdraws or amends its tender or impairs or derogates from the tender in any respect within the period of validity of its tender. SIT 3: Tender Validity: -

SCC-1: Performance Bond/ Security:

The successful bidder shall furnish Security Deposit within 21 days of issue purchase order in the form of unconditional Bank Guarantee/ Account Payee Demand Draft, from any scheduled commercial Bank of India in favor of the "India Government Mint, Noida", for 10% value of the purchase order valid upto 60 days beyond the date of completion of all contractual obligations by the supplier, including the warranty obligations. The defect liability period for the work is One year from the date of completion and acceptance of work.
